

INTERNAL RULES FOR FISHING IN THE ALTO CHIESE – YEAR 2025*

**Please note that the names of smaller rivers, streams and tributaries are shown in these Rules with their original name in Italian (preceded by Rio/Torrente). Italian acronyms have been explained. This is done to avoid confusion when reading signs on site. Fishers must familiarise themselves with Italian signage to avoid violating these Rules. Reservoirs may be signposted locally with "Bacino" preceding the place name.*

Art. 1 FISHING METHODS AND PROHIBITIONS

FISHING METHODS:

- 1- Fishers must comply with provincial law on fishing P.L. No. 60 of 12/12/78 and the fishing regulation of the president of the provincial council No.21-34/leg. of 30 December 2020. Furthermore, fishers must adopt correct conduct during fishing activities with regard to the fish, the environment, other fishers and rangers.
- 2- In order to fish in NO KILL zones 1/2/3/4/5, River Chiese letter E, Val di Fumo, guests and members must make a reservation via the App or through Helga at 348 8449115.
- 3- **MEMBERS, IN ADDITION TO THE OBLIGATION OF A RESERVATION TO FISH IN FISHING ZONE E (Val di Fumo fishing area), MAY ONLY TAKE UP TO A MAXIMUM OF 8 ANNUAL FISHING TRIPS IN SAID FISHING AREA, AFTER WHICH THEY MAY STILL MAKE A RESERVATION TO FISH BUT ONLY NO KILL.**
- 4- Fishing is closed **every TUESDAY and FRIDAY**, with the exception of public holidays.
- 5- **On normal Tuesdays and Fridays (workdays) in the River Chiese MEMBERS and GUESTS** must reserve their fishing trip via the App or through Helga and must do NO-KILL Fly Fishing or Spin Fishing only, as per the rules of ART.7 point 5 for the B/T zone, as per the rules of ART.8 NOKILL1, NO KILL2; as per the rules of ART.9 for zones: NO KILL3, NO KILL4, NO KILL5, (Val di Fumo). All these zones must be reserved via the App or through Helga at 348 8449115 BY BOTH GUESTS AND MEMBERS.
- 6- Before starting to fish, member fishers must fill out the membership card and guests must fill out the day permit.
- 7- Fishing is not permitted after catching and keeping the fifth salmonid, not even to try out equipment, bait or other items.
- 8- It is prohibited to accumulate catches with those made by other fishers.
- 9- Member fishers must have with them during fishing activities, the up-to-date fishing authorisation and the membership card, while guests must have their day permit for the related fishing zone. The documents must be produced at the request of the rangers.
- 10- In relation to others already on site, fishers must keep at a distance so as not to hinder peaceful fishing.
- 11- At the end of each fishing day members must report the total daily catches in the membership card by writing on the right-hand side of the page. At the end of each week, members must add the catches made during the week to those made in previous weeks and write the total in the last box at the bottom of the right-hand page of the membership card.
- 12- In the cases provided for by Art. 22 of P.L. No. 60/78, as amended, fish caught illegally will be confiscated, the membership or the day fishing permit will be suspended according to the methods indicated under the "Penalties" section of these Rules. If an infringement by members or guests is found with the resulting penalty notice, they must hand over the membership card or the day permit.
- 13- In all **flowing waters** the use of 1 (one) rod only is permitted with the use of:
 - 1 (one) hook with a minimum opening of 1 (one) centimetre;
 - or 2 (two) artificial flies;
 - or 1 (one) artificial fly with a maximum of 2 (two) treble hooks;
 - or 1 (one) treble hook;
 - **ALL BARBLESS.**
- 14- In the waters of the **Cimego, Morandino and Dampone** reservoirs the **use of 1 (one) rod only is permitted** with the use of:
 - 1 (one) hook with a minimum opening of 1 (one) centimetre;
 - or with a mosquito or insect lure with a maximum of 5 (five) hooks total;
 - or for artificial flies only, 2 (two) treble hooks.
- 15- In the **Boazzo and Bissina** reservoirs the use of **2 (two) rods** is permitted, using:

- 1 (one) hook only with a minimum opening of 1 (one) centimetre;
- 1 (one) treble hook only per rod, for artificial flies only 2 (two) treble hooks;
- a mosquito or insect lure with a maximum of 5 (five) hooks total.

16- In the Alpine lakes members and guests are permitted to use:

- **2 (two) rods** using 1 (one) hook only with a minimum opening of 1 (one) centimetre;
- 1 (one) treble hook only per rod, for artificial flies only 2 (two) treble hooks;
- a mosquito or insect lure with a maximum of 5 (five) hooks total.

17- GUEST DAY PERMITS ARE CATCH AND RELEASE IN ALL FLOWING WATERS WHERE FLY OR SPIN FISHING IS PERMITTED AS PER ART.9 USING NO KILL METHOD. WITH THE EXCEPTION OF READY-TO-FISH ZONES, J1 WHERE FISHING IS PERMITTED AS PER ART.4. IN THE ALPINE LAKES WHERE FISHING IS PERMITTED ART.1 PARAGRAPH 16. The permit will include the wording for ready-to-fish and Alpine lakes and MUST BE RETURNED AT THE END OF THE DAY. The ready-to-fish (P.P.) zones will be marked with specific start and end signs.

PROHIBITIONS:

- 1- In all flowing waters of the Alto Chiese, with the exclusion of the stretch of the River Chiese in Baitoni and in the River Caffaro, **bank fishing is mandatory until 30 April**, but crossings are permitted provided they are not made while fishing.
- 2- For guests, fishing in Val di Fumo will only be possible with NO-KILL Fly or Spin Fishing as per ART.9.
- 3- The use of a landing net is permitted in all waters, only to remove hooked fish from the water.
- 4- "Starlight" style lights are prohibited.
- 5- It is prohibited to fish with the larva of *Sarcophaga carnaria* (flesh fly) and European bullhead.
- 6- **Fishers may not fish for more than one consecutive day in the same ready-to-fish zone, see Art.4.**
- 7- **It is prohibited to fish with boats or belly boats in all reservoirs.**
- 8- **It is prohibited to fish with live fish and it is prohibited to bring live fish to the fishing location.**
- 9- **It is prohibited to park at or take any vehicle beyond the automatic barrier at the ford of the quarry in the municipality of Borgo Chiese.**

- 1- Annual catches are set at 150 pieces per member.
- 2- In all waters under licence of the Associazione Pescatori Alto Chiese A.S.D., the following may be caught daily: 5 Salmonids, e.g. 2 Trout plus 3 Arctic Char, or 4 Trout plus 1 Marble Trout, remembering to respect the **prohibited** periods and zones.

Art. 3 OPEN SEASON

- 1- The fishing season opens on **the last Sunday of February** and closes on **30 September**. The River Chiese will open in the municipality of Bondone, stretch of the bank on the orographic left of the River Caffaro, left bank of the Rio Riccomassimo and the River Chiese from Storo to the foot of the barrage at the Boazzo reservoir, including the Cimego reservoir and tributaries until the foot of the Morandino reservoir. The opening times of the Morandino, Boazzo and Bissina reservoirs, the upstream tributaries of the Morandino reservoir, River Chiese upstream of the Boazzo reservoir, Alpine lakes, will be communicated by Management as soon as weather permits
- 2- The Rio Ovri, Rio Sacche, Rio Masolivo, Rio Sanotta, Rio Bragone, Rio Visi, Piccole and Torrente Palvico will open on the first Sunday in March.
- 3- The Torrente Lorina, Rio S. Barbara, Torrente Sorino and tributaries, Rio Nero (from the spring to the end of the Prati del Monte zone) and Rio Cala, Prati del Monte zone (Municipality of Ledro, Tiarno di Sopra district) will open on the first Sunday in April.
- 4- The Torrente Giulis beyond the Doss Sorà hill, and its tributaries, will open on the 1st of May.

Art.4 RULES FOR READY-TO-FISH ZONES.

- 1- Ready-to-fish fishing is closed **every TUESDAY and FRIDAY**, with the exception of public holidays.
- 2- The ready-to-fish zones are: Ponte Morandino reservoir, Cimego reservoir. River Chiese, Dampone reservoir, Rio Morbio, Torrente Adanà, Boazzo reservoir, Malga Bissina reservoir, Piana D'Ampola.
- 3- **FISHERS MAY NOT FISH FOR MORE THAN ONE CONSECUTIVE DAY IN THE SAME READY-TO-FISH ZONE, WITH THE EXCEPTION OF ZONES: 2 (MALGA BOAZZO RESERVOIR), 3 (MALGA BISSINA RESERVOIR) 13 (DAMPONE RESERVOIR).**

4- ZONE 4 CIMEGO RESERVOIR

- In all waters of the Cimego reservoir, the use of 1 (one) rod only is permitted with the use of:
 - 1 (one) hook with a minimum opening of 1 (one) centimetre;
 - or with a mosquito or insect lure with a maximum of 5 (five) hooks total;
 - or for artificial flies only, 2 (two) treble hooks.
- On the bridge that leads to the power plant at the Cimego reservoir, fishing is permitted as provided for by Article 16 of the provincial law on fishing.
- Fishers may not park their vehicle near the junction that provides access to the central bridge of the reservoir or on the property of Hydro Dolomiti, where parking is prohibited.
- It is strictly prohibited to go beyond the fence of the reservoir in order to fish.
- **FISHERS MAY NOT FISH FOR MORE THAN ONE CONSECUTIVE DAY IN THE SAME READY-TO-FISH ZONE, WITH THE EXCEPTION OF THE BOAZZO RESERVOIR, MALGA BISSINA RESERVOIR AND DAMPONE RESERVOIR**
- Fishing is not permitted in the lake involved in the Hydro Dolomiti Energia worksite.

5- ZONE 13 DAMPONE RESERVOIR

- In the Dampone reservoir, fishing is permitted inside the signs and the buoys used to signal solar panels.
- In the waters of the Dampone reservoir the use of 1 (one) rod only is permitted with the use of sinkers with a maximum total weight no greater than 8 grams;
- 1 (one) hook with a minimum opening of 1 (one) centimetre;
- or with a mosquito or insect lure with a maximum of 5 (five) hooks total;
- or for artificial flies only, 2 (two) treble hooks;
- It is strictly prohibited to go beyond the fences around the reservoir, and to go beyond the buoys. Transgressors will be punished with the immediate confiscation of the member or day permit, applying the rules on penalties.

6- ZONES C/P (RIVER CHIESE READY TO FISH), J/P1, J/P2 (TORRENTE ADANA' READY TO FISH) R (RIO MORBIO READY TO FISH) and Q/P (PIANA D'AMPOLA READY TO FISH)

- The use of 1 (one) rod only is permitted with the use of:
 - 1 (one) hook with a minimum opening of 1 (one) centimetre;
 - or 2 (two) artificial flies;
 - or 1 (one) artificial fly with a maximum of 2 (two) treble hooks;
 - or 1 (one) treble hook.
- ALL HOOKS MUST BE BARBLESS
- Fishers may not fish for more than one consecutive day in the same ready-to-fish zone with the exception of the Boazzo reservoir, the Malga Bissina reservoir and the Dampone reservoir.

Art. 5 RULES FOR LAKE D'AMPOLA

ART. 6 RULES FOR RIVER CHIESE BETWEEN THE MUNICIPALITIES OF BONDONE AND PONTE CAFFARO.

- 1- The fishing season opens on the last Sunday of February.
- 2- The River Chiese zone includes the stretch up to the existing signpost on the orographic left bank of the river. (The orographic bank is the one in the direction of the current, facing away from the spring, looking towards the mouth).
- 3- Entering the water is permitted and fishing is also permitted in the waterway.
- 4- The use of barbed hooks is permitted provided that the line is cut when releasing the fish.
- 5- It is mandatory to release an undersized fish by cutting the line as close to the hook as possible, causing the least possible harm to the fish.
- 6- The use of any form of mosquito or insect lure is prohibited. Fly fishing is permitted with the use of two flies.
- 7- It is prohibited to fish with live fish and it is prohibited to bring live fish to the fishing location.
- 8- The bank of the river on the orographic left is under licence to Pescatori Alto Chiese A.S.D., while the orographic right bank belongs to the Municipality of Brescia but the water in the river is shared by the two Provinces. For any matters not covered in point 3 of these internal rules, the provisions of the general internal rules and the provincial regulations apply.

Art. 7 RULES ON TOURIST FISHING ZONES (BT)

- 1- This zone is found along the River Chiese in the Municipality of Borgo Chiese and is marked with the letters **B/T** and indicated by specific signs along the river.
- 2- **Bank fishing is mandatory until 30 April**, but crossings are permitted provided they are not made while fishing.
- 3- For any matters not covered by the rules, the provisions of the law and the internal fishing rules currently in force apply.
- 4- **Members** are permitted to use all authorised fishing techniques and **ALL HOOKS MUST BE BARBLESS.**
- 5- To fish in the aforesaid zone, **guests** must make a reservation via the App or by contacting Helga at 348 8449115, because entries are limited:
 - It is prohibited to keep the caught fish. All caught fish must be unhooked with utmost care and must never be taken from the water; use of the landing net is mandatory.
 - Spin fishing is permitted with artificial flies, spinners, swimbaits and rapala lures, silicone flies, with spinflies **ALL ON A SINGLE HOOK**
 - Fly fishing is permitted with mice tails, "Valsesiana" flies, Tenkara flies, strike indicators (floats), with dry flies, terrestrial flies, nymph flies or streamer flies, all with a single fly and a maximum of 2 (two) hooks.
 - **ALL HOOKS MUST BE BARBLESS.**

Art.8 NO-KILL1, NO-KILL2

- 1- To fish in the aforesaid zone **MEMBERS** and **GUESTS** must have a reservation made via the App or by phoning Helga at 348 8449115. **GUESTS** must hold the specific permit for **NO-KILL1** or **NO-KILL2**, members must score out the boxes for their catch on the day they will go fishing in this zone and must catch and release for the entire day.
- 2- Access to this zone is only permitted with fishing equipment, landing net and accessories, no baskets or other containers for transporting fish caught in other zones are allowed.
- 3- **Bank fishing is mandatory until 30 April**, but crossings are permitted provided they are not made while fishing.
- 4- It is prohibited to keep the caught fish. All caught fish must be unhooked with utmost care and must never be taken from the water; use of the landing net is mandatory.

- 5- Fly fishing only is permitted with mice tails, "Valsesiana" flies, Tenkara flies, strike indicators (floats), with dry flies, terrestrial flies, nymph flies or streamer flies, **all with a single fly and a maximum of 2 (two) hooks.**
- 6- **Fishing may not begin before 7 AM** and must end one hour after sunset.
- 7- **ALL HOOKS MUST BE BARBLESS.**
- 8- **Silicone flies are prohibited.**
- 9- The **NO-KILL1** zone is in the Municipality of Borgo Chiese, in the River Chiese it begins from the border with the Associazione Pescatori di Storo (just above the confluence of the Torrente Sorino), it ends at the ford that crosses the Chiese leading to the quarry. This zone, marked with specific signposts, is called NO-KILL1.
- 10- The **NO-KILL2** zone is in the Municipality of Pieve di Bono-Prezzo, situated in the Chiese it begins upstream of the north bridge of the Cimego reservoir, until the end of the municipal road "Via al Ben" (start of the fenced private property). This zone is marked with specific signposts and is called NO-KILL2.
- 11- After fishing in the NO-KILL2 zone it is permitted to continue fishing in the River Chiese from the end of the NO-KILL2 zone down towards the Morandino reservoir, always using CATCH AND RELEASE and respecting the rules of NO-KILL2

Art. 8bis RULES FOR LAKE COPIDELLO

- 1- The fishing season opens on a date decided according to the weather.
- 2- FOR BROOK TROUT ONLY (*fontinalis* or American) the minimum size is 15 (fifteen) cm and the maximum daily number is 5 (five) pieces.
- 3- It is prohibited to catch Arctic char.
- 4- The use of 2 (two) rods is permitted using 1 (one) hook only with a minimum opening of 1 (one) centimetre or 1 (one) treble hook only per rod, for artificial flies only, 2 (two) treble hooks, the use of a mosquito or insect lure with a maximum of 5 (five) hooks total.
- 5- **On the day dedicated to fishing on Lake Copidello it is not permitted to fish in any other neighbouring fishing zone before or after.**

Art. 9 NO-KILL3, NO-KILL4, NO-KILL5

1. To fish in the aforesaid zone MEMBERS and GUESTS must have a reservation made via the App or by calling Helga at 348 8449115. GUESTS must hold the specific permit for NO-KILL3, NO-KILL4 and NO-KILL5 depending on the zone they have reserved and members must score out the boxes for their catch on the day they will go fishing in this zone and must catch and release for the entire day. Access to this zone is only permitted with fishing equipment, landing net and accessories, no baskets or other containers for transporting fish caught in other zones are allowed. Guests must make a reservation to fish in the aforesaid zones because entries are limited.
2. The **NO-KILL5** zone is situated in the River Chiese in Val di Fumo, it begins in SERRA where a very visible sign is posted, for 2 km upstream, where there will be another sign indicating the end. Catch and release fishing is also permitted in the stretch of the River Chiese marked by the letter **E** (from the Bissina reservoir to the start of NOKILL5 and from the end of NOKILL5 to the spring).
3. The **NO-KILL4** zone is situated in the River Chiese downstream of the Bissina reservoir, it begins from the Ortigheta bridge until the waterfall upstream of the **PIANA DI NUDOLE** plain where there will be another sign indicating the end. Catch and release fishing is also permitted in the stretch of the River Chiese marked by the letter **D** (from the Boazzo reservoir to the start of NOKILL 4 and from the end of NOKILL 4 to the Bissina reservoir).
4. The **NO-KILL3** zone is situated in the River Chiese 4 km from the town of Daone, in the direction of Pracul. It starts from the Dastion bridge until Vermongoi, where there will be a sign indicating the end. Catch and release fishing is also permitted in the stretch of the River Chiese marked by the letter **C/1** (from the Morandino reservoir to the start of NOKILL3 and from the end of NOKILL3 to the Boazzo reservoir).

5. The zones are marked with specific start and end signs that read **INIZIO** and **FINE** respectively.
6. **Fishing may not begin before 7 AM** and must end one hour after sunset.
7. **Bank fishing is mandatory until 30 April**, but crossings are permitted provided they are not made while fishing.
8. It is prohibited to keep the caught fish. All caught fish must be unhooked with utmost care and must never be taken from the water; use of the landing net is mandatory.
9. Spin fishing is permitted with artificial flies, spinners, swimbaits and rapala lures, silicone flies, with spinflies **ALL ON A SINGLE HOOK**
10. Fly fishing is permitted with mice tails, "Valsesiana" flies, Tenkara flies, strike indicators (floats), with dry flies, terrestrial flies, nymph flies or streamer flies, all with a single fly and a maximum of 2 (two) hooks.
11. **ALL HOOKS MUST BE BARBLESS.**

Art.10 OCTOBER FISHING (PO)

- Fishing is permitted in October with the following limitations and requirements: **FLY FISHING** with mice tails, Tenkara flies, "Valsesiana" flies, with dry flies, nymph flies, spinflies, all with a single fly or with a maximum of 2 flies or nymphs on barbless hooks. **SPIN FISHING** with 1 artificial, spinner, minnow, swimbait armed with a single hook, spinflies, all with barbless hooks.
- **MEMBERS AND GUESTS ARE REQUIRED TO MAKE A RESERVATION** via the App or by contacting Helga AT 348- 8449115 IN ORDER TO FISH IN THE AFORESAID ZONES P.O.1, P.O.2, P.O.3, P.O.4.
- It is strictly prohibited to keep the caught fish and all fish must be released without causing harm (catch & release).
- It is prohibited to use silicone flies, rubber flies, bait pastes and natural flies.
- Artificial flies longer than 6 cm are prohibited.
- Use of the landing net is mandatory.
- Fishing may not begin before 7 AM and must end one hour after sunset.
- Guests must return their completed permit to the site it was purchased from or place them in the mailbox at the site of the Associazione PESCATORI ALTO CHIESE A.S.D. fr. Cologna, 46.

OCTOBER FISHING (PO) ZONES

- **PO1 River Chiese (from the start of No-Kill1 to the Cimego dam) FLY FISHING ONLY PERMITTED.**
- **PO2 River Chiese (from the north bridge of the Cimego reservoir, to the bridge downstream of the Morandino reservoir) FLY AND SPIN FISHING PERMITTED.**
- **PO3 River Chiese (from upstream of the Morandino reservoir to downstream of the Boazzo reservoir) FLY FISHING ONLY PERMITTED.**
- **PO4 River Chiese (from upstream of the Boazzo reservoir to downstream of the Bissina reservoir) FLY FISHING ONLY PERMITTED.**

Art. 11 PENALTIES

- 1- In all confirmed cases of violation, in addition to the penalty notice, the Association reserves the right to take legal action against the transgressor for reimbursement of the damages arising from the transgression.
- 2- For any matters not covered in the above rules, the provisions of the general internal rules and the provincial regulations on fishing P.L. No.60 of 12/12/78 and fishing regulation No.21-34/LEG of 30 December 2020 apply.

- 3- Members issued a penalty who continue to fish, even with a day permit, will be declared *personae non gratae* and may have their membership card confiscated. Members whose membership card has been confiscated have no right to any reimbursement.
- 4- First-time transgressors of any of the points or letters of these Rules, be they members or guests, will have their membership or temporary permit confiscated for 30 (thirty) fishing days.
- 5- Members or guests who violate any point or letter of the internal rules in the same TWO-YEAR PERIOD for 1 (one) other penalty will have their membership or temporary permit confiscated for **60 (sixty) fishing days**.
- 6- Members or guests issued with the same penalty in the same TWO-YEAR PERIOD will have their membership or temporary permit confiscated for **90 (ninety) fishing days**.
- 7- For members or guests who are issued with 3 penalties, the current Management will decide how long they will be considered *personae non gratae*.
- 8- All outstanding penalties in the same fishing year will be brought forward to the following year of the membership.
- 9- PENALTY DAYS ARE COUNTED EXCLUDING NON-HOLIDAY TUESDAYS AND FRIDAYS

IMPORTANT NOTICES

- 1- Members, in addition to the obligation of a reservation to fish in zone **E** (Val di Fumo fishing area), may only take **A MAXIMUM OF 8 ANNUAL FISHING TRIPS IN SAID FISHING AREA**, after which they may still make a reservation to fish but only NO KILL. (as per Article 1, paragraph 3 of the internal rules)
- 2- It is strictly **PROHIBITED TO LEAVE WASTE** of any kind in the fishing zones, either on the banks or in the water.
- 3- Fishers are requested to pay close attention to the signs stating "**POSSIBILITA' DI PIENE IMPROVVISE**", which indicate the possibility of sudden floods.
- 4- All fishers are requested to pay close attention when using carbon fibre rods or similar alloys near **POWER LINES** or during a storm.
- 5- All fishers are asked to immediately report to the rangers any dangerous situations or **ENVIRONMENTAL POLLUTION OR DAMAGE** they discover.
